INTRODUCTION TO OUR WINE CLUB

Our label simply states our philosophy. The creation of SV Cork Club is to share that philosophy with serious wine lovers and those individuals on their way to becoming wine lovers!

SV CORK CLUB BENEFITS

There are three membership levels. 8 cork members, 12 cork members and 24 cork members. Benefits of each are the same except for the discount levels and yearly purchasing commitment. The purchasing commitment for 8 cork members is eight (8) bottles per year with four (4) bottles per shipment, for the 12 cork members the commitment is twelve (12) bottles per year with six (6) bottles per shipment and for the 24 cork members the commitment is twenty-four (24) bottles per year with twelve (12) bottles per shipment. All other benefits are as follows:

CORKS AND SCREWS

Members agree to a 1 year commitment, 2 shipments, and may cancel at any time after the 2nd shipment. Each Cork Club shipment will be Winemaker's choice with a mix of our current release wines. The price range for each shipment will be approximately \$80 to \$270 depending on membership level, excluding shipping/handling and taxes. At the time wine is shipped your credit card will be charged for the wine, shipping/handling, and taxes in applicable states.

Certain states restrict shipments of wine to consumers, so please check with us if you do not see your state listed on the membership form. You may make changes to your enrollment level or cancel membership at anytime after your one year commitment and you will only be charged for wines shipped. Alcoholic beverages may only be sold and delivered to persons who are at least 21 years of age and a signature is required at delivery so you may want to have it delivered to a business address. **For questions contact the winery at info@SweetValleyWines.com**

Shipments will include sales tax in applicable states. It is my obligation to inform Sweet Valley Wines in writing of any changes in address, telephone numbers or credit card changes prior to the wine club shipment. This will greatly expedite timely shipment of your wine. Sweet Valley Wines will not be responsible for shipping charges incurred due to misdirected packages. I understand that my credit card will be charged for all re-shipments. Wine purchases are non-refundable. During times of extreme weather conditions, Sweet Valley Wines has the right to postpone shipments. Due to state-specific restrictions, we can only ship to the following US states and with some restrictions: AK, CA, DC, FL, IA, MN, OR, WA. If you do not live in one of these states, please call the winery for more information.
